Our semi-private option on a public cruise offers an exclusive space for your group, separate from other cruise guests. Enjoy your own floor with easy access to the bar and outdoor deck—perfect for a more private, memorable experience. If you want to make it extra special, you can decorate the space 30 minutes before boarding starts.

*The total cost of a semi private deck rental includes the deck rental fee, cost of tickets, plus a gratuity of 20% for your party. Subject to blackout dates, availability, and group size. A minimum guest count is required to book.*

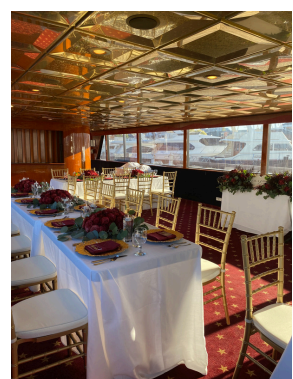
Our Upper Deck rental offers a semi-private space on our yacht, providing a unique setting with beautiful views and access to a full-service bar.

Due to USCG Rules and Regulations, all guests must have access to the entire yacht at all times, which means that other public guests may use the bar and the outside upper deck area. We also offer lower deck and total boat buyouts for larger groups.

For public cruise buyouts - the menu, timing, setup, background music, and décor is not changeable.

This rental is subject to availability, blackout dates, and specific group size requirements.

The total cost of a deck rental includes the deck rental fee, cost of tickets, plus 20% gratuity automatically added for your party.

# Public Cruise Deck Rental

Our Upper Deck option offers a semi-private space at a lower cost than a full buyout. Your group enjoys its own floor with quick access to the bar and outer deck. While other guests can also use the outer deck, there are multiple outdoor areas available, and most order through their servers rather than the upstairs bar—so your group will have a comfortable, exclusive feel.

*The total cost of a semi private deck rental includes the deck rental fee, cost of tickets, and gratuity for your party. This cost does not include additional food or drink. Subject to blackout dates, availability, and group size. A minimum guest count is required to book.*

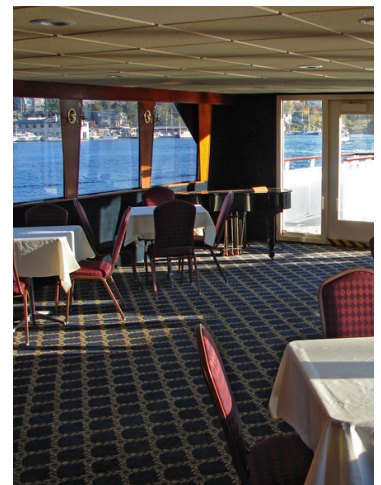

# Terms & Conditions

*The deck rental is a semi-private space. Pursuant to USCG Rules and Regulations, all guests must have access to all areas of the yacht at all times. Therefore, other public guests will be able to purchase drinks at our full-service bar located on the upper deck, and will have access to the wheelhouse and the outside upper deck.*

1. Subject to blackout dates, availability, and ticket minimum.
2. A gratuity of 20% of the total cost of tickets is mandatory.
3. When a client books an upper deck on a public cruise - menu, timing, setup, and décor is not changeable.
4. No outside food or drinks are allowed onboard. Exception would be corkage fee of \$30 applied to bottle of wine.
5. Minimum ticket number must be met – no exceptions.
6. Children under the age of 5 are not included in guest count. Children under 13 are not allowed on our dinner cruises.
7. As safety is always our first priority, we ask that customers not run, climb, jump, or adhere to any behavior that would put themselves or other passengers at risk and in danger of falling overboard, tripping and/or falling.
8. Due to USCG Regulations we must account for all guests onboard, including infants. Final passenger headcount is due at least 14 business days prior to the cruise date, along with final payment.
9. Purchase of enhancements are allowed - Packages, appetizers, etc.
10. Hosted Bar (based on consumption) or drink ticket options available.
11. Holiday pricing: \$500 on top of all base rental fees for special event cruises (Wine Pairing, Holiday Dinner, etc.)
12. Current promotions and group discounts are not applicable for public buyouts, private, or semi-private events or spaces.
13. Decor: Waterways prohibits glitter, confetti, and adhesive including all tape or anything that adheres to the yacht.

## Deadlines

*The total cost of a semi-private upper deck rental includes the rental fee, cost of tickets, and gratuity for your party. This cost does not include additional food or drink.*

*Subject to blackout dates and availability. A minimum of 12-20 tickets purchased based on cruise date is required to book.*

- A deposit of 65% of the total price is required to hold the boat on booking. Full payment is required for the minimum tickets one month after booking or 14 days before the cruise whichever comes first.
- Once booked, NO REFUNDS, only rescheduling is available. Rescheduling will result in a fee of \$500. Please let us know at least 14 business days in advance if you need to reschedule.
- The final head count, any additional payments and entrée selections\* (if applicable - dinner only) is required at least 14 business days prior to cruise date. Full payment must be received at this time.

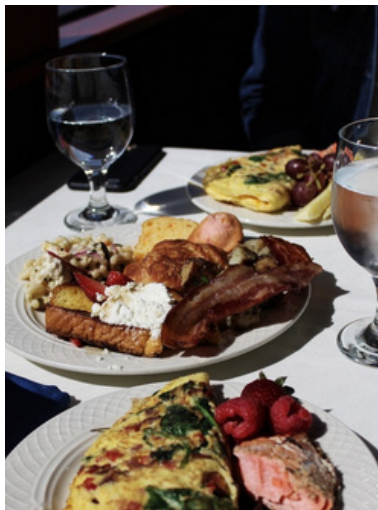

- The final head count, any additional payments and entrée selections\* (if applicable - dinner only) is required at least 14 business days prior to cruise date. Full payment must be received at this time.
